Introduction

Election Commission of Maldives (herein referred as ECM) invites vendors to submit proposal for “Point to Point Fiber Connectivity”. ECM requires implementation services to complete all components of this project including consultancy in the process of implementation, configuration, etc.

Purpose

The purpose behind issuing this RFP is to provide information for technical and commercial bids from eligible bidders for the above purpose.

Scope of Work

1. Installation of Single Mode 8 Core Fiber Optic cable between Old Drug Court Izzuddeen Magu, Malé) and Elections HQ (Third Floor, Port Complex Building, Hilaalee Magu, Malé).
2. The Vendor must provide rack mounting fiber termination panel included with accessories at both ends.
3. Fiber optic specification (Technical Specifications in Annex-1)
4. Point to Point Link specification (Technical Specifications in Annex-2)

Expectations from Bidders

1. The vendor must have a minimum of 2 (Two) project experience of Point-to-Point Fiber Connectivity delivered locally (Letter from the client confirming the completion of the project).

Delivery and Installation Schedules

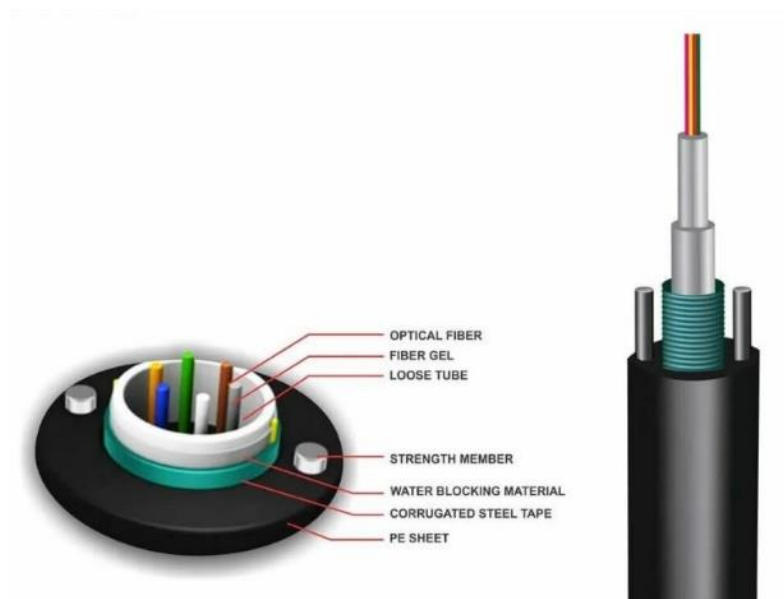
1. The deadline for submitting the required materials to the Commission and completion of Installation is Maximum **25 days**.
 - i. This 25-day period will commence from the date of signing the agreement, and it includes public holidays.
 - ii. The successful bidder must sign the agreement within 3 days from the date of award of the project.
1. After completion of installation the bidder should obtain sign-off on the Installation-cum-Acceptance certificate from the ECM official. ECM will carry out acceptance of hardware as per acceptance test plan.
 - a. Installation will be treated as incomplete in one/all of the following situations:
 - i. Non-delivery of any software or other components, accessories, documentation, drivers, media mentioned in the order.
 - ii. Non-delivery of supporting documentation.
 - iii. Delivery, but no installation of the components and/or software.
 - iv. System operational, but unsatisfactory to ECM.
